## INVITATION MESSAGE FROM THE PRESIDENT OF IABA

ÁNGEL BRUNO

**Dear members of the Inter - American Bar Association (IABA - FIA)  
and from friendly international organizations :**

1) It is a great pleasure for me, as President of the Association, to contact you and invite you to participate as a protagonist in our next Conference, which we will hold, in person, in the City of Miami, FL - USA, from June 16th to June 20th.

2) The Organization Committee is working hard to repeat and even improve the great success obtained in the recent Conference held in Rio de Janeiro just three months ago. There we saw each other face to face again after four years of doing it only through screens, due to the pandemic crisis. The joy of the reunion, the warmth of our conversations and the enthusiasm that caused us to feel our closeness again, allowed us to definitively appreciate the need to rebuild a network of warmth and friendship, solidarity and mutual help among all, allowing that the IABA can fully meet its objectives.

The Local Committee has been established, with the leadership of Arturo De Sola and Carolina Obarrio, as decided by the Council in its last meeting, and several more members of the Chapter of that City, who have once again made themselves available to the IABA, such as our former presidents Renaldy Gutiérrez, Tony Santos, Jhon Rooney, Ed Vidal and Fallon Trujillo, among others. All of this in coordination with the Executive Committee and our General Secretary.

Likewise, our General Rapporteur, Jesús Rivera Oré, together with our General Secretary, Lourdes Venes, are in the midst of organizing the Academic Program, which will, without a doubt, be of an excellent level. There have already been meetings with the authorities of the IABA Committees, who are fully committed and are beginning to develop their proposals. An effort will be made to ensure that the academic sessions are interactive, making participants present previous written presentations, and then can develop them during the work session, giving rise to exchanges and conclusions. We will all be protagonists.

We have the expectation and firm conviction that this Conference will repeat the success of the one in Rio. Not only for its work sessions, but also for seeing each other again and continuing with the line of presence that, as we have been saying, is the basis on which the network of friendship, warmth and camaraderie is built, which is the living fabric from which the IABA will be able to achieve its objectives.

3) I want to make you an invitation with content, not just formal. You know that my message from the first day I assumed leadership of the IABA was one of unity. Seek to rebuild those ties of friendship, cordiality, solidarity and camaraderie that I consider to be the vital fabric on which the Association will be able to fully develop and achieve its goals.

With democratic, pluralistic and tolerant leadership, I did not support the idea of the “new IABA”, because the IABA is not from before or now, it is a collective construction, carried out with the contribution of everyone and in permanent dynamics and development. All of us, with our pluses and minuses, have contributed to this construction and it is not fair that divisions are made or valuable efforts are left behind. Everyone inside, no one outside or excluded, knowing how to accept and live with our differences. That is why it is important to talk about the essentials.

For this I have set a couple of high standards: **ONE)** The standard of unity, consensus, harmony and joint growth. I believe that this standard is shared by the vast majority, because they have made it known to me in multiple ways, and in that way I drive with confidence and support. I have regained the leadership of the President's role and will continue to do it until the end of the mandate that you gave me.

I have also set another high bar regarding the role of lawyers, which seems fundamental to me: **TWO)** We are not only here to defend our clients in a fair trial. I wish to highlight that it is also up to us to work towards the construction of a just society, which guarantees social peace. That is our vocation.

We must not forget that justice is, according to Ulpian's universally accepted definition, “giving to each his due.” And each one's own is what each one requires to live with dignity. Starting with life itself, and then with the care of that life: health, food, housing, work, education, security: these elements, along with others, are the components of the Common Good, that are the essential conditions for human beings, who are equal by nature, to develop fully. At the beginning of time, men competed with each other, but they realized that in this way and through their own effort, they would not be able to access everything they needed, and they began to outline forms of collaboration and division of labor, and formed their first communities, which later led to what is today the State. They put aside rivalries where only the powerful prospered and put mutual aid into practice, and this replaced the “law of the jungle” and “every man for himself” with solidarity. The purpose of the State will be to guarantee the Common Good, which is what it was created for. Common Good whose conditions make up basic human rights. We must not forget that commutative justice, which is what we seek in our daily work when defending our clients, and which we achieve by obtaining a fair sentence against two parties in conflict, is complementary to distributive justice, as we are taught in our Law Schools from the first year. Social Justice, which distributes efforts among everyone, with those who have the most contributing more, so that everyone has what is essential. Lawyers must contribute to the construction of a more just and supportive society, where, as Pope Francis says, there is no injustice in that there are so few who have so much and so many who have so little or nothing.

There are two paradigms in conflict today: On one hand, individualism and selfishness, return to the law of the jungle or, on the other hand, solidarity, shared effort and mutual and fraternal help. I aspire for the IABA to recognize and support the role of lawyers in the construction of that just, peaceful, egalitarian and inclusive world, with full validity of human rights and the Common Good, where it governs the Rule of Law and Social justice. This is the other high bar that I leave raised as one of the legacies of my leadership, which I exercise with full guidance and with strong ideas, concrete proposals and multiple actions developed.

We will talk about all this at the Conference, in institutional spaces and also in informal ones. I hope for everyone's necessary participation in these debates.

**4)** All this being said, I invite you now to make the necessary preparations so that everyone can be present. I hope to see you at the next Conference in Miami. I send a big hug to all of you, hoping to be able to give them to you in person soon.
